Applicants who have submitted applications against previous notifications / news items / personally, need to apply afresh in the prescribed application form.

**Eligibility Criteria:**

1. Applicants should be Indian Nationals.
2. **Age:** Applicants should have completed 18 years as on the last date of submission of applications for franchise. Copy of Matriculation or Secondary School Leaving Certificate indicating date of birth or Voters ID card issued by Election Commission shall be submitted as proof of age.
3. **Educational Qualification:** Pass in SSLC (10<sup>th</sup> STD) or equivalent examination.
4. **Residential Status:** Residents of Karnataka can apply for all locations. Residents of India belonging to other States can apply for franchise outside the State of Karnataka only. Copy of voters ID card or Driving Licence or Passport shall be furnished as address proof. Insurance Policy, Telephone Bills, Bank passbook are not accepted as address proof.
5. **Disqualification:**
  - a. Persons who have been convicted for criminal offence involving moral turpitude / economic offences (other than Freedom struggle) are not eligible.
  - b. Totally paralysed or mentally unsound persons (who suffer from insanity) are not eligible.
  - c. Totally Deaf, Dumb or Blind persons are not eligible.
  - d. Franchisees whose agreements were terminated by KSRTC or sister STUs of Karnataka for proven malpractices / violations are not eligible.
  - e. Public servants are not eligible. They can apply if they are willing to resign from their current employment for considering the appointment as Franchisee.
  - f. Persons dismissed / removed from the services of State / Central Government or their undertakings including KSRTC and its sister Corporations are not eligible.
  - g. Existing Franchisees of KSRTC are not eligible.

Eligible applicants fulfilling above criteria may obtain application form, terms and conditions and other details from the office of the Director (Operation), KSRTC, Central Offices,

K.H. Road, Bangalore on payment of **application fee (non-refundable) of Rs.500/- (Rupees five hundred only)** through Demand Draft drawn in favour of the Chief Accounts Officer cum Financial Advisor (CAO-FA), KSRTC, Bangalore **during office working hours from 12.10.2009 to 22.10.2009.**

Applicants desiring to obtain Application Forms by post are required to send application fee through Demand Draft drawn in favour of CAO-FA, KSRTC, Bangalore to the Director (Operation), KSRTC, Bangalore along with a self-addressed envelope of size 5” x 9” affixing postage stamps of Rs.20/-. KSRTC will not be responsible for late receipt of applications due to delay in transit.

Applications are to be submitted in the prescribed application form and shall be accompanied by **Earnest Money Deposit of Rs.10,000/- (Rupees ten thousand only)** through Demand Draft drawn in favour of the Chief Accounts Officer cum Financial Advisor, KSRTC, Bangalore. EMD paid by the applicant will be adjusted towards security deposit in case of applicants selected as Franchisee and refunded in case of applicants not selected as Franchisee.

Sealed covers with filled-in application forms and prescribed enclosures be dropped in the box kept in the office of the Director (Operation), KSRTC, Central Offices, K.H. Road, Bangalore on or before **1300 hrs on 23.10.2009.** Sealed covers will be opened at **1500 hrs on 23.10.2009** in the presence of the applicants or their representatives.

KSRTC reserves absolute right to accept or reject any application for any location without assigning any reasons.
